Concerns raised by Alec, that students have been made aware that we are no longer offering the Local AA Degree. Students on the D yard are being denied graduation because they have not been counseled or provided an education plan. As a group we have agreed to allow the below:

- 4.1 If the student has an education plan with continue on with their plan.
- 4.2 If the student started prior to Fall 2018 and does/doesn't have an education plan but it's been communicated to them, they will have the option of Local / IGETC pattern
- 4.3 If the student started with us in Spring 2019, the student will ONLY complete an IGETC pattern.
