## 5. Faculty re-orientation

Discussions held amongst the group on how we can better serve our faculty members who serve our incarnated student population. Ideas to include Canvas site/Course – the possibility and logistics for holding this class for credit/certification. As well as making it available to other faculty members outside of the college/district. Corey raises concerns and doesn't support the model as it was previously developed for the online teaching faculty.

Peter has been looking into a platform called Bridge. Action item: Peter to send Corey information and pricing. Innovation grant could pay for the startup but how are we able to fund the platform going forward? Benefits of the platform include, "One Stop Shop", can house forms and documents such as the training manuals, CDCR rules and guidelines, the ability to track a faculty member's progress, i.e. training, security clearances, etc.

### 6. Enrollment Growth

#### **Identified Concern:**

There is uncertainty surrounding the current funding formula. ISEP's intensive growth has outstripped Cerro Coso's ability to get students on education plans and provide the kind of tutoring and other learning support that we know makes a quality program. It



has been proposed that in order to assist student services, the prison program was not going to add any *new enrollments* for the summer and fall 2019 semesters.

It has been identified that ISEP increased the *number of courses* offered at both prisons for summer/fall 2019, which has brought concern for possible new enrollments.

**Note**: Due to the number of impacted classes at both facilities, a very limited number of students are able to apply and come off the waitlist for classes. CAC has not accepted any new students into their program during AY2018-19.

#### **Response to Concern:**

ISEP has increased the number of courses available for a number of reasons, but most notably the **creation of AD-T pathways** as mandated by the State Chancellor's office. Additional ISEP courses were added due to:

- Implementation of AD-T pathways during spring 2019
   RESULT: Education plans are being given to students based on the AD-T core classes. Students now have a clear pathway towards completion of a transferable degree within 2 years.
- Decreased Traditional Student Enrollment
   RESULT: At the request of faculty chairs and Deans during spring 19 and summer/fall 19 semesters, courses were added in order for full-time faculty to meet their load requirements (i.e. Tom Heck)
- New Courses Requested
   RESULT: Faculty chairs requested courses to be added (i.e. LIBR C100, MATH C131); LIBR has developed a 3-unit course that could be implemented in fall 2019 and attract more enrollment.

**Note**: Reducing the number of courses offered will affect *enrollment*, **NOT headcount** of individual students. It will obstruct the number of units students will be able to take – decreasing the number of FTES, and time it takes to complete a degree. The average completion/transfer rate is 7-8 years for Cerro Coso overall. It has been suggested that we "incentivize students to take more classes each semester and so lower the time to completion".

### **Student Services/Education Plans & Counseling Contacts:**

It is **NOT recommended** to cut courses as a way to decrease the number of students to allow for student services to "catch up".

## According to Cognos Matriculation Report as of 4/23/19:

CAC & CCI Combined, looking at students in the 201930 term only (because if they are not taking a class this term, they most likely have transferred/paroled/or completed)

• 56% have NO ED PLAN marked



44% have either an ASEP/CSEP/Exemption

**Note**: Anna/Karee have met with at least 200 students this term at CCI and *will have* Ed plans for each of them by the end of the summer term (logged once a letter goes out to student, even though they've already had counseling contact and discussed Ed Plan). When we account for these 200 students as having received their Ed Plan, the **NEW DATA IS**:

- 23% have NO ED PLAN marked
- 77% have either ASEP/CSEP/Exemption

Due to the incredible strides our counselors (Anna/Karee/Devin/Ayanna) have made during this spring 2019 semester, we will have gone from 44% to 77% of our incarcerated students having an Education Plan and counseling contacts completed (that's a **33% increase** in one term!).

If courses are cut from the proposed schedule, those education plans will have to be rewritten and adjusted for the limited number of courses available to reach degree completion.

#### Proposal:

If we must continue to address the concerns by cutting courses down to a 10% growth, a new baseline must be set. Due to AD-T's beginning in spring 2019, it is not accurate to compare growth from summer/fall terms between academic years and we propose comparing summer/spring terms for comparison instead.

#### **Baseline Year**

2018 Summer and 2019 Spring (Tehachapi) = 55 2018 Summer and 2019 Spring (Cal City) = 54 Total= 109 x 10% = **120** courses

\*This class was added so that Tom Heck could make load for the 2018-2019 academic year (per Dean & chair request) and 2019-2020 academic year.

#### Results:

Canceling 13 courses over summer and fall equals a **total loss of 32.9 FTES** and 390 enrollments. Known loss of 12.8 FTES for already registered summer students and 20.1 FTES potential loss for fall.

 $32.9 \text{ FTES } \times \$5,500 = \$180,950$ 

[Sum of (Unit load \* 30 students) \* 16 weeks]/525 = FTES The FTES is derived from the assumption that one student is enrolled in courses for 3 hours a day, 5 days a week, for an academic year of 35 weeks. This means **one FTES** is **525 hours of instruction** (3 x 5 x 35 = 525) in the academic year.
